Declaration of PCT Education @ Study in China Application/Admission/Scholarship Policies

I: General Policy

- 1.1. All applicants could choose to apply through PCT Education or other agents. Suppose you choose to apply through a third party who applies for application /admission/ scholarship for you via PCT Education. In that case, we are not responsible for extra costs, damages, or other legal issues. What you pay for "PCT Education" is for the service we provide. By paying us a service fee, you mean agreeing with our Terms-Conditions and refund policy.
- 1.2. Before paying for PCT Education @ Study in China, students should check the parts of the required documents on the "Application Procedure" page carefully and can consult again and again with our expert consultants.
- 1.3. All students' information and application documents must be real.
- 1.4. Applicants who are awarded any form of financial aid like Chinese Government Scholarships or Chinese university scholarships can't apply for scholarships repeatedly. You should be aware of this before using our service.
- 1.5. Although you will have a high chance of getting admission/scholarship by using our services, PCT Education never guarantees a 100% success rate for applying for admission/scholarship because the universities make the ultimate decisions for admission based on students' documents and previous academic activities.
- 1.6. Applicants should check their email regularly and contact the consultant who is following your file in case of missing any information once they booked our services. Applicants who fail to check email/communicate regularly need to bear the inconvenience resulting from that.

1.7. Applicants are obligated to submit all necessary information and documents before the application deadline. Failure to comply may result in the applicant assuming responsibility for any resulting losses.

1.8. Applicants who successfully get scholarships should ensure that they study hard to retain the scholarships as required by their various institutions.

- II: Applicant's Right
- 2.1. Applicants have the right to choose universities and programs but we appreciate not selecting any specific city or university when applying for a scholarship because it's too competitive, so in most cases we would apply to the best fit for the applicants according to the schools we find and have higher chances of accepting applicants.
- 2.2. Applicants have the right to know scholarship details such as the service fees before applying, and the ongoing process of application.
- 2.3. Applicants have the right to claim a refund according to our refund policy as below.
- **III: Refund Policies**
 - 3.1. Applicants need to pay application and processing fees of \$200 (which is non-refundable) before the application starts.
 - 3.2. PCT Education has the right to change the service fee before a student applies. But once students pay application fees, and start applying, there won't be any changes.
 - 3.3. Applicants choosing PCT Education cooperating university scholarships could get a refund if the application failed.

We, PCT Education are now offering application services to students who want to apply in China. To avoid casual applications and make sure we offer application/admission/scholarship to those in need.

Application Fees

The application when applying is \$200

- A. Before applicants' applications start with the institutions, we charge \$200 for the application and processing fee which we also pay to the schools, and is quite non-refundable in any circumstances but students will get free application services in other universities.
- B. If the admission/scholarship application failed in a targeted university or subject, we will apply for more alternative scholarships and universities which is a completely free service for our applicants.


C. Because of misfortune if we fail that semester for admission and scholarship, we will try for next semester without the applicant paying another application fee.

Note: After getting any of the scholarship offer, Service applies.

Service Fees Structure.

Partial Scholarship: \$2000 (partial tuition fees covered)Full Scholarship: \$3000 (Tuition Fees covered)Full Scholarship: \$3200 (Tuition fees, and accommodation)Full Scholarship plus allowances: \$3500 (Tuition fees plus allowances)

- D. After receiving all original papers (Admission + Scholarship +JW form) by courier, if applicants don't submit papers for visa or change intention will not get refunded any money as they paid after the JW form was issued by the university.
- E. Submitted papers (like bank statements, Medical reports, Police clearance, academic papers, etc) but not sufficient as per the embassy requirements, and any fraudulent document found from the applicants' application documents which led to visa refusal by the embassy, applicants will not get a refund as we do not support applicants submitting fake documents for university applications.
- F. If students are refused a visa due to the university documents' issues, though the applicant has all authentic documents (which we will investigate), PCT Education will refund all service fees except \$300 for documentation and courier charges. The refund will be paid within 2 months upon application for refund by the student and as they meet refund policies.
- G. Subjective on partial scholarship /deposit fee /Tuition fee if students need to pay university before the JW form is issued and Students some fail to get visas due to reasons outlined in point (F) on the side of the university.
- H. We don't issue a refund if the applicant asks for a visa process extension letter to be given by the university, and the university helps to send the extension letter but the applicant still doesn't meet the deadline even after getting the extension letter.





- I. Due to the epidemic/pandemic, service fees are non-refundable as schools provide online learning experiences within those periods before the applicants return to the university for offline learning after the epidemic/pandemic.
- J. Receiving documents (original Admission Letter +JW form) lately or finally not received due to wrong mailing address, in that cases service fee is non-refundable.

Applicants, upon payment and signing of the **T/C** form with PCT Education, commit to adhering to the outlined refund policy. Non-compliance with the refund policy applies to scholarships that are nonrefundable. Applicants found providing fake documents, failing to submit documents on time, or refusing a scholarship after acceptance by the university will not be eligible for a refund. The declaration serves as a signed contract between students and PCT Education, outlining responsibilities for issuing refunds as stipulated in case of non-compliance.
